### **Requirements:**

Please ensure that your Temporary "By the Glass" Patio Expansion Request contains the following information.

- □ Completed Temporary "By the Glass" Patio Expansion Request application form, including description summarizing the patio/café proposal;
- Sketch of Proposal identifies proposed size and dimensions of patio/cafe, detail of fencing or barriers to be used, patio seating capacity and identifies size and number of existing parking spaces and any proposed to be occupied;
- □ Site drawing of property, including all existing buildings, site features and parking areas:
- Signed Parking Agreement Appendix "I", (If proposed patio does not comply with Zoning Bylaw parking requirements, signed parking agreement is required);
- □ Letter of support from Landlord or property owner, (if different from applicant);
- □ Copy of Current Liquor Sales License (if area is to be licensed);

I/we hereby understand that the Government has amended Regulation 719 under the *Liquor Licence Act* (LLA) for Manufacturer's (i.e. wineries, breweries and distilleries) with a Limited Liquor Sales Licence (commonly known as a "By the Glass" Licence), to temporarily extend the physical size of the existing outdoor licensed patio or to temporarily add a new licensed patio within the approved period, are authorized to do so, if the following criteria are met:

- 1. The physical extension of the premises is adjacent to the licenses premises under the "By the Glass" licence;
- 2. The municipality in which the premises is situated has indicated it does not object to an extension;
- 3. The licensee is able to demonstrate sufficient control over the physical extension of the premises;
- 4. There is no condition on the "By the Glass" licence prohibiting a patio;
- 5. The capacity of any new patio, or extended patio space where the licensee has an existing licensed patio, does not exceed 1.11 square metres per person, and
- 6. The sale and service of the wine, beer and/or spirits manufactured by the manufacturer within the physical extension of the premises is primarily aimed at promoting the manufacturer's product and either providing an enhanced tourist experience or fulfilling an educational purpose.
