1. COMMUNITY OVERVIEW

The Township of Muskoka Lakes is located in the heart of the District of Muskoka, situated at the southern tip of the Canadian Shield. About two million years ago, this section of the Shield was covered by a series of glaciers, which left behind the numerous lakes that define the municipality today. The Township encompasses a large geographic area around Lakes Muskoka, Rosseau and Joseph. Within the approximately 780 square kilometers in the Township's jurisdiction, lie over 80 lakes and rivers, numerous wetland complexes, bedrock outcrops, islands, all set amongst a mix of vegetation types and natural heritage areas. The natural beauty of the shorelines and the abundance of wildlife make Muskoka Lakes a world renowned and preeminent tourism and recreational living destination.

The Township's population consists of approximately 6,600 permanent residents (2016 Census) and over 27,000 seasonal residents. While the permanent residency is predominantly located in six un-serviced communities, two serviced urban centres, and the rural area, the seasonal residents reside primarily in the waterfront area. With the majority of the more highly assessed properties located in the waterfront area, at over \$11 billion in assessed property value (Municipal Property Assessment Corporation 2018), Muskoka Lakes has the largest assessment base in the District of Muskoka.

Given the high quality living opportunities in the waterfront and rural areas, over the last 20 years, the Township has witnessed unprecedented growth along the shores of its lakes and to a lesser degree in the rural area. Although much of this is individual residential lot development on Lakes Joseph, Rosseau and Muskoka, larger scale proposals, development on medium and small lakes and commercial development also play an important factor. According to the Ministry of Municipal Affairs and Housing Building Permit Statistics 2021, Muskoka Lakes construction value for building permits to date is at totaled \$90,911,758.65.

In addition to maintaining a road system of 380 km of local and rural roads in the Canadian Shield, the Township owns and operates ten fire stations, twelve community centres, two arenas, and multiple parks, trails, picnic areas, playgrounds, municipal docks, lake access points and launch ramps, beaches, spread throughout the municipality. To assist with the prioritization of the maintenance, repair, and in some cases the replacement, of this infrastructure, the Township is currently preparing an asset management plan. This plan will inform a long term sustainable financial plan.

The Township of Muskoka Lakes Fire Department consists of ten fire stations staffed by 125 volunteer firefighters under the direction of a full-time Fire Chief. There is a full-time Deputy Fire Chief, a full-time Fire Prevention Officer and full-time Administrative Assistant in the Administrative office in Port Carling. The fire stations are located in Port Carling, Minett, Windermere, Raymond, Milford Bay, Foot's Bay, Glen Orchard, Bala, Torrance, and Walkers Point covering an area of 795 square kilometres. The Township of Muskoka Lakes Fire department currently provides public education, code enforcement and fire suppression services with volunteer firefighters.

2. PROJECT INTRODUCTION & BACKGROUND

A review provided the background for the development of the current Fire Master Plan occurred in 2013 and examined all aspects of the Fire Department operations such as fire prevention, public safety education, emergency response, firefighter training, administration, finance, human resources, facilities, maintenance, and compliance with industry standards. That review resulted in the following recommendations:

- Improved direction for the Fire Department through updates to applicable By-laws;
- More accurate tracking of public education and fire prevention activities;
- Facility improvement requirements;
- Increased training and record keeping; and
- Improvement of approaches for recruitment and retention of volunteer firefighters.

The former Fire Master Plan has served, and continues to serve, as the guiding document for the Township to create priorities for Council on annual basis since its adoption in 2015. In addition, the plan has been used to guide Staff's reports and recommendations to Council in policy, procedures and/or operational matters.

As most of the current (2014) Master Fire Plan recommendations have been addressed, new fire administration has been hired, recent Provincial regulatory requirements for community risk assessments have been established, as well as Council's desire to review the Ten Year Capital Forecast in more detail, a review and update of this plan is warranted.

The Township of Muskoka Lakes is seeking the services of a qualified consulting team with extensive experience in Master Fire planning and project facilitation to create a new Master Fire Plan. The selected consultants will be working closely with the Fire Chief, staff and Township Council.

The Fire Master Plan would be completed in two (2) phases:

Phase 1 requires the consultant to complete a Community Risk Assessment following the best practices as found in the Office of the Fire Marshal and Emergency Management Technical Guideline OFMEM-TG-02-2019. The risk assessment will identify fire and life safety risks and prioritize to determine which risks to address and how best to address them.

Phase 2 would see the consultant complete a comprehensive review of the Departments current service delivery program. The analysis will focus on an assessment of current conditions and delivery performance of the departments emergency services including administration, fire prevention public education, training, fire suppression, apparatus, facilities and staffing. The results of this assessment must then inform recommendations for continuous improvement of the fire service in order to respond to the factors identified in the Community Risk Assessment. This may include, but not be limited to streamlining of services and rationalization of infrastructure.

4. PROJECT OBJECTIVES & FOCUS

- 4.1. The selected consultants will work with the Fire Chief, staff and Township Council to develop a Master Fire Plan. Taking into consideration the future growth of the community, the Fire Master Plan must assist Council in providing the level of fire

protection services in the Township of Muskoka Lakes to address the factors identified in the Community Risk Assessment and the requirements of the Fire Protection and Prevention Act (FPPA) in an efficient and cost-effective manner.

- 4.2. It is expected that the review and update of the Fire Master Plan must be based upon:
- 4.2.1. A review of background information will be essential to the Fire Master Plan in order to develop achievable and appropriate priorities.
 - 4.2.2. Completion of a community risk assessment based on the geographic, built environment and seasonal demographic characteristics of the Township;
 - 4.2.3. A review of all current fire services and fire programs, based upon the above risk assessment. This analysis must also include an examination of the department's core functions, including, but not limited to administration, fire prevention, public education, training, fire suppression, apparatus, facilities, and training. The review of the fire services and programs must consider and include recommendations respecting:
 - 4.2.3.1. Continuous improvement to the services (administration, suppression, training, public education, prevention,) currently being provided;
 - 4.2.3.2. The Plan will describe the strategy for aligning Muskoka Lakes Fire Department services with the goals and objectives of the Township's Strategic Plan. This includes, but is not limited to addressing capital investment and equipment needs over the next 10 years, as well as major operational components that help drive core services. This external audit will define what the optimal level of service looks like for the Fire Department as well as how fire operations needs could evolve to respond to growth including anticipated investments required to meet those needs.
 - 4.2.3.3. Another component of the Fire Master Plan will be an assessment of the facility needs and recommended strategies to address those needs. The current locations of stations should be considered and evaluated based on industry best practices and projected community growth, in order to inform recommendations respecting the most appropriate number and location of stations needed in the future. A starting point for this component is the suggestions of the 2014 Master Fire Plan, regarding replacement of facilities;
 - 4.2.3.4. Evaluate the current staffing model for full time and part time staff. This component would also include recommendations in regards to recruitment and retention of volunteer firefighters; and
 - 4.2.3.5. Continuous Improvement to the communications system, maintenance program and non-suppression services;
 - 4.3.3.6 Benchmarking current services and programs against current industry standards and known guidelines, as well as compliance with current legislative requirements; and
 - 4.3.3.7 A Community Consultation Program respecting initial findings and input on the desired level of service and any proposed recommendations thereon.
- 4.3. As the Fire Master Plan will be used by staff to prepare their annual business plans and budgets, the

Plan must include recommendations/goals that are SMART (specific, measurable, achievable, realistic and time framed) and rooted in today's (and tomorrow's) reality; and recognize trends and emerging realities.

- 4.4. It is also expected that any final recommendations to improve or alter the Township's fire services for the next five to ten years which may be included in the Master Fire Plan, will be identified in short, medium and long term planning horizons. These recommendations must also contain associated implementation strategies and be sensitive to the financial and political realities of the community regarding the provision of fire services.
- 4.6 The Township understands that there are a variety of models and approaches that can be used to develop a Fire Master Plan. The selected consultants are required to include in their proposal a recommended methodology to meet the project deliverables within the scope and constraints provided as well as examples of similar projects that they have completed.

5. SCOPE AND CONSTRAINTS

- 5.1. The selected consultants are required to ensure that the Community Consultation Program component of the Master Fire Plan update project maintains or improves upon a number of key attributes as described below:
 - 5.1.1. Transparent and consistent communications and messaging to elected officials, firefighters, municipal staff and the residents of the Township of Muskoka Lakes;
 - 5.1.2. Ensure a range of opportunities to consult with, and engage, all fire personnel in the review process; and
 - 5.1.3. In addition to other forms of communication, utilize the Township's website with the assistance of the Township's Communications Coordinator to communicate information about the project and the related process to the public.
- 5.2. It is hoped that the Proponent will be able to expedite the project while at the same time providing an opportunity for meaningful stakeholder input.

6. PROJECT DELIVERABLES

- 6.1. The consultant will be responsible for providing expert advice throughout the project and for the following deliverables (note that proponents are not limited by the deliverables and may wish to expand on them):
 - 6.1.1. Project Plan & Coordination The consultants will prepare a project plan with a schedule outlining reporting and or decision points where written status reports will be provided to the Township's satisfaction. The consultants will coordinate regular meetings to keep the project on schedule and keep identified stakeholders apprised of the process;
 - 6.1.2. Needs Assessment and Environmental Scan The consultants will review the existing Fire Master Plan and background information pertinent to development of a Master Fire Plan, identifying trends and patterns that are applicable, analyzing strengths, weaknesses, opportunities and threats;

7. REPORTING

The Consultant will be required to provide electronic copies of all draft and final reports in Microsoft Office and PDF files on a memory stick or through any agreed upon electronic transfer in the timeframes identified by the Township. Any materials used for presentations, consultations or open houses to be provided in both hard copy and electronic format as required.

8. RESOURCES

8.1. The Fire department's staff will assist with logistics, setting up of meetings, communications with committee/public utilizing existing contact databases and social media channels, etc. Existing plans and documents to be utilized for the environmental scan will be provided in hard copy or electronically.

8.2. In most cases, public input sessions will be held via zoom.

9. PROPOSED FEE

9.1 The Proponent shall submit a detailed fee proposal identifying all costs associated with the proposed work plan.

9.2 Identify any out-of-pocket expenses & disbursements, separately.

9.3 Identify on the work plan the deliverables and the delivery timelines for each draft report.

11. CONTENT OF PROPOSALS

- 11.1. The proposal should include the Respondent's interpretation of the requirements of the project, together with a description of the approach planned to facilitate carrying out the terms of reference, schedule of tasks and decision points. In addition, the proposal should include:
- 11.1.1. A statement of experience and expertise in strategic planning; public consultation and project facilitation;
 - 11.1.2. If applicable, a list of all sub-consultants to be engaged by the prime consultant, with details of the areas for which each will be responsible;
 - 11.1.3. A list of key personnel who will be assigned to the project, identifying the areas of expertise of each and indicating their involvement in the project;
 - 11.1.4. Identification of a Project Manager;
 - 11.1.5. A detailed cost estimate for the project to include manpower costs per individual, the per diem rate and the proportion of costs for each part of the workplan;
 - 11.1.6. Clarification of specific requirements of the Township of Muskoka Lakes and/or any exclusion from the scope of the work;
 - 11.1.7. Based on the Terms of Reference, a work plan indicating key decision points, timing of work and meetings with the Township; and
 - 11.1.8. References from other similar clients.

12. FEES & COSTS

14. PROPOSAL SUBMISSION FORMAT

INSTRUCTIONS TO RESPONDENTS

Respondents are required to provide a written response regarding each of the following items.

This information shall be submitted with the balance of the required documents provided by the Respondent however, it is **essential** that the **document FORMAT** be contained as one distinct section and, that it **adheres directly to the same numbering, sequence and topics** as those listed following.

This will enable the evaluation committee to perform a more effective review of submissions.

Failure to do so may eliminate the Proposal from further consideration.

The Respondent's proposal should be as concise as reasonably possible, and include, at a minimum, response to each of the following items:

Section 1 Company Overview

Clearly identify the prime firm submitting the proposal. Identify any other firms that may be involved (sub-contracted) on your behalf and their legal/contractual relationship with the prime firm along with the expertise and respective projected costs of their involvement.

Section 2 Project Manager & Support Staff

Provide a resume of the Project Manager and Support Staff that would be directly involved in the project, indicating experience, credentials and notable achievements in the area of this work assignment. Evaluation of the Project Manager and Project Support Staff will include an assessment of the firms overall ability to provide adequate resources to this project.

The Township will expect these key personnel to be committed to the project as described in the proposal, if successful with the award, any changes in these personnel must be approved, in advance, by the Township.

Section 3 Experience on Similar Projects

Respondents shall include at least three (3) References that outline previous

community strategic planning for projects of a similar magnitude that have been successfully completed by their firm in the past five (5) years. This shall include the client names, contact and contact phone numbers. The Township reserves the right to contact these references, where appropriate. In the interest of fair and equitable consideration to all Respondents, please do not list the Township of Muskoka Lakes as a reference for this Section.

Note that each reference is not to exceed one 8.5"x11" page in length and one picture, a maximum one quarter the size of the page, is allowed.

Section 4 Project Understanding and Work Plan

Respondents are to confirm their understanding of the Scope of Work and clearly define how they would go about to achieve same, including noting the sequence and timing of all project phases.

Section 5 Schedule of Work

Respondents shall indicate when work would be commenced and, approximately how long it would take to complete the assignment. Meeting dates, other key events and major project deliverables should be clearly identified on the project schedule.

Section 6 Financial

Prices quoted in the Proposal shall include excise tax, patent, import duty, foreign exchange, and all other charges. HST must be shown as a separate item.

Appendices Respondents are to include any additional information regarding their firm and/or services that could prove beneficial to the evaluation team in accessing their submission.

Respondents are required to include in their response, the Respondent's Declaration as shown in Appendix "A" to this RFP.

16. EXAMINATION OF REQUEST FOR PROPOSAL DOCUMENTS

Each Respondent must satisfy himself/herself by a personal study of the RFP documents, by calculations, and by personal inspection of the public information available from the Township. There will be no consideration of any claim, after submission of proposals, that there is a misunderstanding with respect to the conditions imposed by this RFP.

Prices must include all incidental costs and the Respondent must be satisfied as to the full requirements of the RFP. No claims for extra work will be entertained and any additional works must be authorized in writing prior to commencement. Should the Respondent require more information or clarification on any point, it must be obtained prior to the submission of the RFP.

The RFP will be posted and available for download on the Township's website beginning September 15, 2021 and will remain available until closing on September 29, 2021.

21. LATE SUBMISSIONS

Proposals received after the official closing time will not be considered during the selection process and will be returned unopened to the respective Respondent.

22. PROPOSAL WITHDRAWAL

22.1. A Respondent who has already submitted a proposal may submit a further proposal at any time up to the official closing time. The last proposal received shall supersede and invalidate all proposals previously submitted by that Respondent.

22.2. A Respondent may withdraw their proposal at any time up to the official closing time by notifying the Project Manager in the email provided. Such a submission must be received in sufficient time to be marked before 4:00 p.m. on the date for closing of proposals.

22.3. No Respondent may withdraw their proposal for a period of 60 days after the actual date of closing.

23. PROPOSAL OPENING

Respondents are advised there will not be a public opening for this RFP. Submissions received, by the date and time of closing, will be opened administratively by respective members of the Township at a time subsequent to the closing.

24. ACCEPTANCE OR REJECTION OF PROPOSAL

- 24.1. The acceptance of a proposal will be contingent upon, and not necessarily limited to, an acceptable record of ability, experience, and previous performance.
- 24.2. The Township reserves the right to reject any or all proposals and to waive formalities as the interests of the Township may require without stating reasons therefore.
- 24.3. No proposal shall be accepted from or awarded to any individual, partnership or corporation that is in current or pending litigation, or tax arrears, with the Township of Muskoka Lakes, or that may be deemed irresponsible or unreliable to the Township. Notwithstanding and without restricting the generality of the statement immediately above, the Township shall not be required to award and accept a proposal or recall the proposals at a later date:
 - 24.3.1. When only one (1) proposal has been received as a result of the proposal call;
 - 24.3.2. Where the lowest responsive and responsible Respondent's proposal substantially exceeds the estimated cost of the goods or service;
 - 24.3.3. Where the proposal documents do not state a definite, or are based on an unreasonable delivery/work schedule;
 - 24.3.4. When all proposals received fail to comply with the specifications or proposal terms and conditions; or
 - 24.3.5. Where a change in the scope of work or specifications are required.

26. VERIFICATION OF INFORMATION

The Township shall have the right to:

- 26.1. Verify any Respondents statement or claim by whatever means the Township deems appropriate, including contacting persons in addition to those offered as references; and/or
- 26.2. Access the Respondent's premises where any part of the work is to be carried out to confirm Proposal information quality of processes and to obtain assurance of viability; and/or
- 26.3. The Respondent shall co-operate in the verification of information and is deemed to consent to the Township verifying such information.

27. SELECTION PROCESS

- 42.1. The Successful Respondent at their sole cost and expense shall insure its activities in connection with the work under this Agreement and obtain, keep in force, and maintain insurance as follows:
- 42.2. Comprehensive General Liability Insurance including but not limited to bodily injury including death, personal injury, property damage including loss of use thereof, broad form contractual liability, Townships and contractors' protective, products and completed operations and contain a cross liability, severability of insured clause in an amount of not less than two-million dollars (\$2,000,000.00) applying to all claims on a per occurrence basis. The policy shall include the Township as additionally insured in respect of all operations performed by or on behalf of the Successful Respondent.
- 42.3. Non-Owned Automobile Liability Insurance (SPF 6) in an amount of not less than \$2,000,000.
- 42.4. Professional Liability (Errors and Omissions) Insurance in the amount of two million dollars (\$2,000,000) per claim and five million dollars (\$5,000,000) in aggregate. Such insurance shall provide coverage for all errors and omissions made by the professional in the rendering of, or failure to render, professional services in connection with the work under this Agreement. Upon completion of the work under this Agreement, the policy shall remain in force for twelve (12) months. The insurance shall not have a retroactive date less than prior to the placement of this policy or coinciding with the effective date of this Agreement. If a retroactive date should apply to this policy, confirmation that the retroactive date is not in effect after the commencement of work under this Agreement must be included in the certificate of insurance.
- 42.5. Prior to commencement of any work associated with this Agreement and upon the placement, renewal, amendment, or extension of all or any part of the insurance, the Successful Respondent shall promptly provide the Township with confirmation of coverage and, if required, a certified true copy(s) of the policy(s) certified by an authorized representative of the insurer together with copies of any amending endorsements applicable to any work associated with this Agreement.
- 42.6. All policies shall be endorsed to provide 30 days advance notice to the Township of any modification, change, or cancellation.

42.11 It is expected by the Township that the Certificate(s) of Insurance will provide confirmation that all insurance requirements as stated under Section 23 have been met.

42.12 If applicable and based upon the operations of any sub-contractor, Section 23 shall apply in the same manner to any sub-contractor as it would to the Successful Respondent. Further, it is the Successful Respondent's obligation to ensure that any sub-contractor is aware of these obligations. The Successful Respondent shall provide to the Township confirmation of the sub-contractor's insurance.

43. REGULATION COMPLIANCE AND LEGISLATION

43.1. All work provided must be in accordance with all laws and regulations pertaining to the work. The laws of the Province of Ontario shall govern this proposal and any subsequent agreement resulting from this proposal.

48. PERFORMANCE

Any undue delays in the execution of the work and/or costs incurred by the Township due to inefficiencies in performance on behalf of the successful Respondent shall be deemed the responsibility of that Respondent and as such, any and all costs, as deemed appropriate and reasonable compensation for the Township, will be assessed to the Successful Respondent.

52. CONFIDENTIALITY UNDERSTANDING

The successful Respondent and its employees may have access to information confidential to the Township. This information may include, but is not limited to, terms of this agreement, business methods and systems, contractual terms, pricing, personal information, etc. subject to disclosure by force of law, the successful Respondent agrees that it and its employees who have access to this information shall not either during the term of the agreement or at any time thereafter reveal to any
