McTaggart, Jean-Ann Baranik, Linda Barrick-Spearn, W. Ron Brent, and Greg Knight. Mr. Gill reviewed his concerns and reasons for the six requests with respect to the legislation, website and advertising expenses (People for Probity), and the sharing of joint expenses when campaigning as a group or slate. In addition, he submitted and reviewed a presentation addressing the above reasons along with the following; explanation for supplemental information related to Don Furniss' finances, internet / social media expenses and a donation related to Greg Knight's finances, expense allocations and detail documentation related to W. Ron Brent's finances, and signage expenses related to Gault McTaggart's finances.
