NOTICE OF PUBLIC HEARING OF APPLICATION FOR MINOR VARIANCE

LOCATION OF PROPERTY: Part Lot 21, Concession 7, Parts 3 to 5, Plan 35R-3117, Parts 3

and 4, Plan 35R-19938, Parts 1 and 2, Plan 35R-26056 (Medora), Civic Address: 1114 Halls Road, Zoning Schedule: 28

EXPLANATION OF THE PURPOSE AND EFFECT: The subject property is zoned Waterfront Residential (WR5-7) and is located on a Category 1 Lake (Lake Rosseau).

The applicant proposes to recognize an as-built shed and attached sundeck.

Relief is requested from Section 4.1.3 of By-law 2014-14, as amended, being a minimum front yard setback requirement of 66 feet for a shed. The as-built shed has been constructed 17.5 feet (at the closest point) from the front lot line. The requested variance is 48.5 feet.

Relief is also requested from Section 4.1.4 of By-law 2014-14, as amended, being a minimum front yard setback of 50 feet for a sundeck. The as-built attached sundeck has been constructed 18.5 feet (at the closest point) from the front lot line. The requested variance is 31.5 feet.

NOTICE: This notice has been sent to you for your information and does not require any response unless you wish to make one. The above noted application will be heard by the Committee of Adjustment on the date and at the time shown below.
