EXPLANATION OF THE PURPOSE AND EFFECT: The applicants propose to sever a portion of their property (Severed Lot) and to add it to an abutting lot to the east (Benefitting Lot) in the ownership of Tracey Seaward and Daniel Majaina. The Severed Lot is vacant. The Benefitting Lot contains a dwelling, sleeping cabin, shed, boathouse and dock. The Retained Lot is vacant.

This application will result in a change in common lot lines. No new lot is proposed to be created.

A KEY MAP of the subject land and a consent/severance sketch are included in this notice.

FAILURE TO PARTICIPATE IN HEARING: If you do not participate in the hearing it may proceed in your absence and, except as otherwise provided in the Planning Act, you will not be entitled to any further notice in the proceedings.

NOTICE OF DECISION: If you wish to be notified of the decision of the Committee of Adjustment in respect of this application, you must submit a written request to the Committee of Adjustment.

NO ONE OTHER THAN the applicant, the municipality, certain public bodies and the minister may file an appeal of the decision of the Committee of Adjustment in respect of the proposed consent. If a person or public body that files an appeal of a decision of the Committee of Adjustment in respect of the proposed consent does not make written submissions to the Committee of Adjustment before it gives or refuses to give a provisional consent, the Ontario Land Tribunal may dismiss the appeal.
