NOTICE OF PUBLIC HEARING OF APPLICATION FOR MINOR VARIANCE

Planning Act, R.S.O., 1990, c.P.13,45(5), R.R.O., 1980, Reg. 787

APPLICATION MADE BY: Philip and Shauna Walton, 69 Kimbark Blvd, Toronto, ON M5N 2X9

LOCATION OF PROPERTY: Lot 9, Concession 5, Part of Lot 27, Plan M-119, (Wood), Civic Address: 1059 McKenzie Road, Unit 20, Zoning Schedule: 49

EXPLANATION OF THE PURPOSE AND EFFECT: The subject property is zoned Waterfront Residential (WR6) and Waterfront Residential – Restricted Waterbody (WR6-R) and is located on a Category 1 Lake (Lake Muskoka).

The applicants propose to construct a dock addition.

Relief is requested from Sections 4.1.7 and 4.1.7.19 a. of By-law 2014-14, as amended, being the maximum permitted dock length within a Restricted Waterbody Zone. In this case, the maximum permitted dock length is 40 feet. The proposed dock addition will result in a dock length of 44 feet. The variance requested is 4 feet.

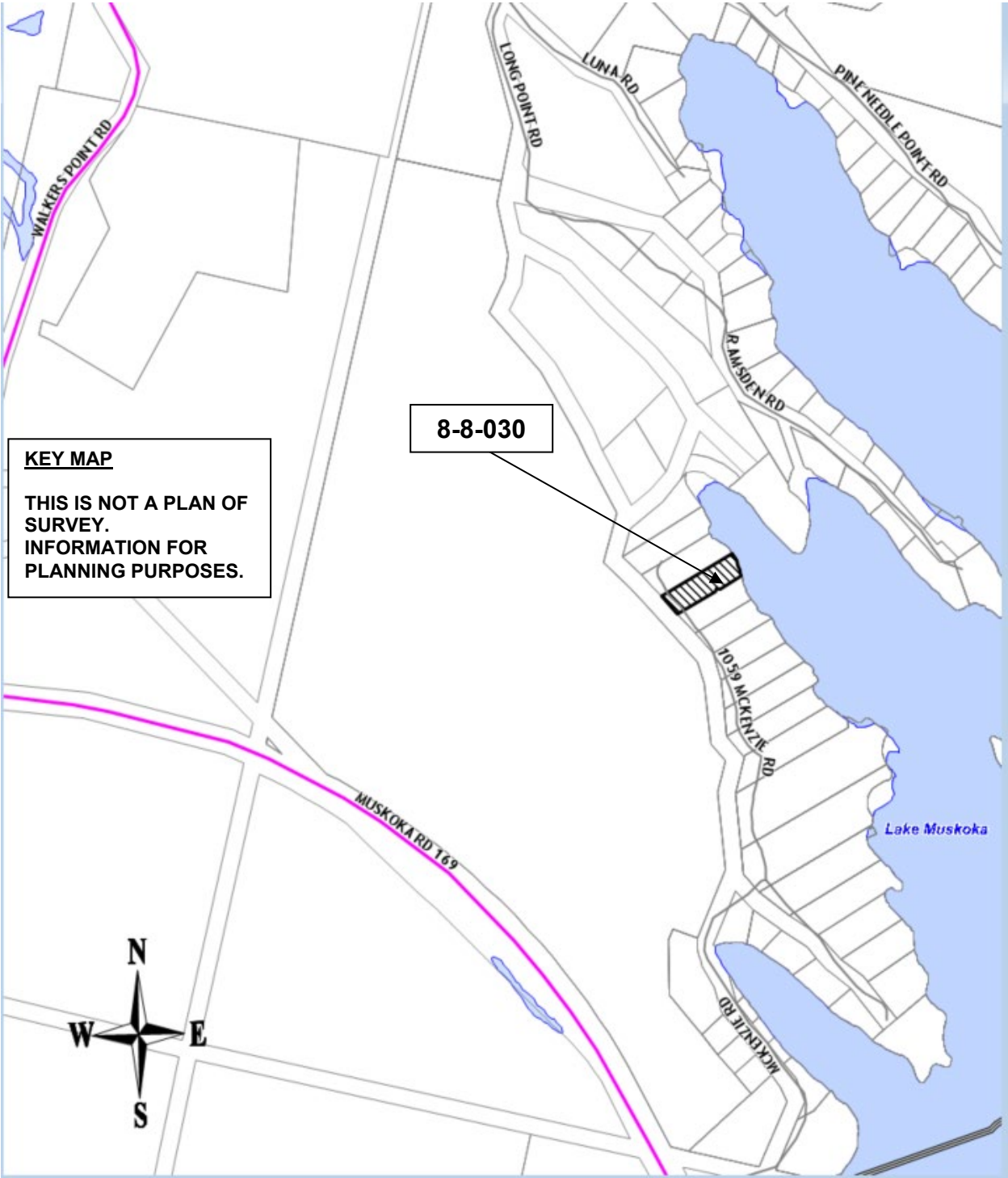

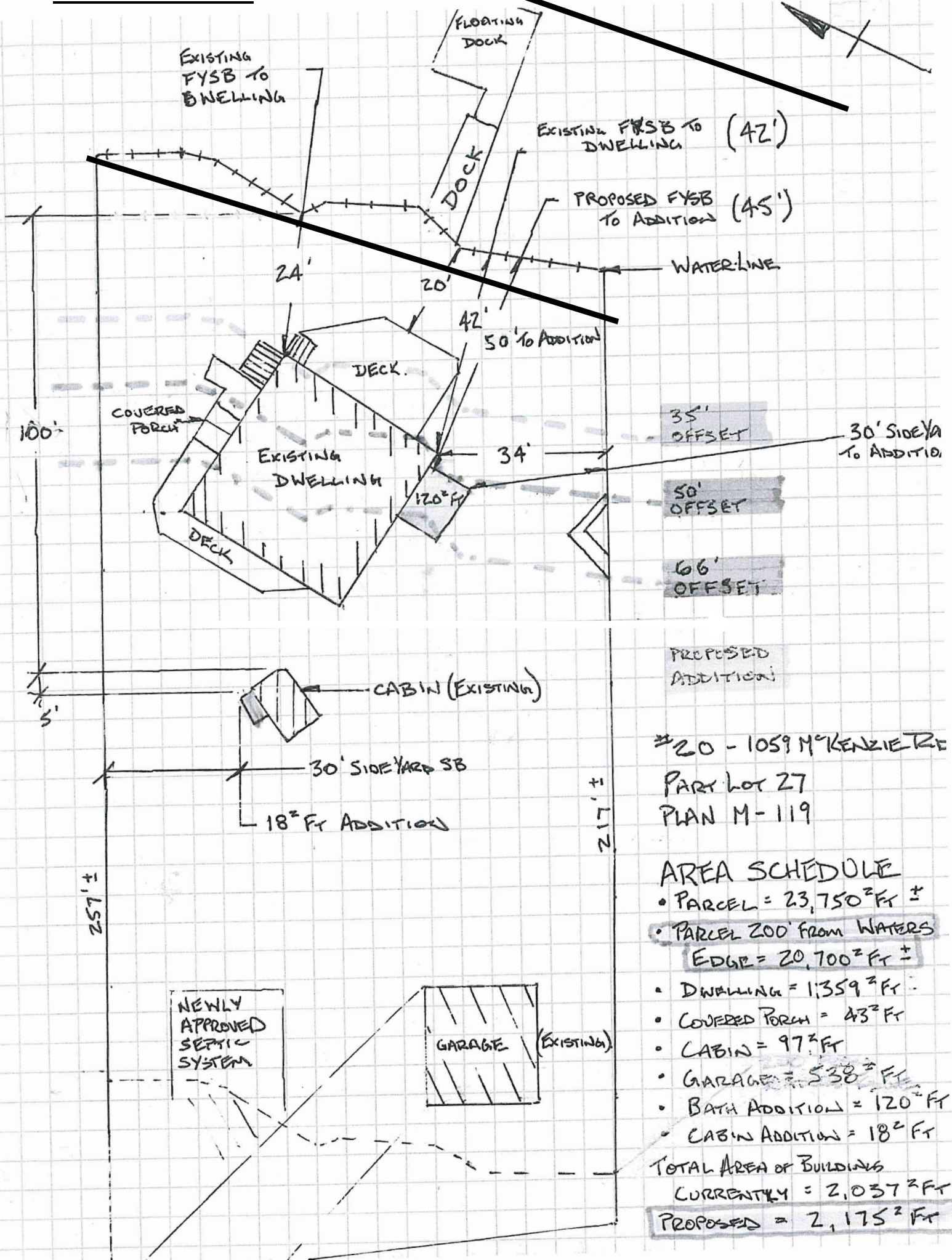
