NOTICE OF PUBLIC HEARING OF APPLICATION FOR MINOR VARIANCE

Planning Act, R.S.O., 1990, c.P.13,45(5), R.R.O., 1980, Reg. 787

APPLICATION MADE BY: John Welton, 148 Shaws Road, Blue Mountains ON L9Y 0R7

LOCATION OF PROPERTY: Part Lot 17, Concession 5, (Medora), Parts 7 and 8, Plan 35R-10830, Parts 5 and 6, Plan 35R-15952, and Parts 1 and 2, Plan 35R-26440, Civic Address: 1232 Halls Road, Zoning Schedule: 28

EXPLANATION OF THE PURPOSE AND EFFECT: The subject property is zoned Waterfront Residential (WR5-7) and is located on a Category 1 Lake (Lake Rosseau/Joseph River).

The applicant proposes to recognize an existing storage building.

Relief is requested from Sections 4.1.3.6 and 4.1.3.7 of By-law 2014-14, as amended, being the maximum permitted coverage of buildings (lot coverage) on a lot within 200 feet from the high water mark on a Category 1 Lake. The maximum permitted lot coverage of buildings within 200 feet from the high water mark is 10%. In this case, the lot area within 200 feet from the high water mark is 60,100 square feet. Therefore, the maximum permitted lot coverage within 200 feet from the high water mark is 6,010 square feet. The coverage of existing buildings within 200 feet from the high water mark is 6,010 square feet or 10.7%. The variance requested is 393 square feet or 0.7%.
