

Township of Muskoka Lakes Notice of Study Completion Transportation Master Plan

The Township of Muskoka Lakes has developed a Transportation Master Plan (TMP) Study to create a safe and reliable transportation system within the Township. This master plan will strive to address the needs of all stakeholders, creating a vision for all modes of transportation.

The Study was carried out in accordance with the Phase 1 and 2 of the master plan process outlined in the Municipal Class Environmental Assessment (October 2000, as amended in 2007, 2011 and 2015), which is approved under the *Ontario Environmental Assessment Act*. The Study follows Approach #1 of Master Plans under the *Municipal Class Environmental Assessment (MCEA)* process which is a broad level assessment requiring more detailed investigations at the project-specific level in order to fulfill the MCEA requirements.

The TMP Study considered and evaluated solutions to determine a safe, environmentally and economically sustainable, and efficient transportation network.

30-Day Review Period

The TMP is being placed on the public record and will be available for a 30-day review period starting April 22, 2024 and ending May 22, 2024 to meet requirements of the MCEA process. 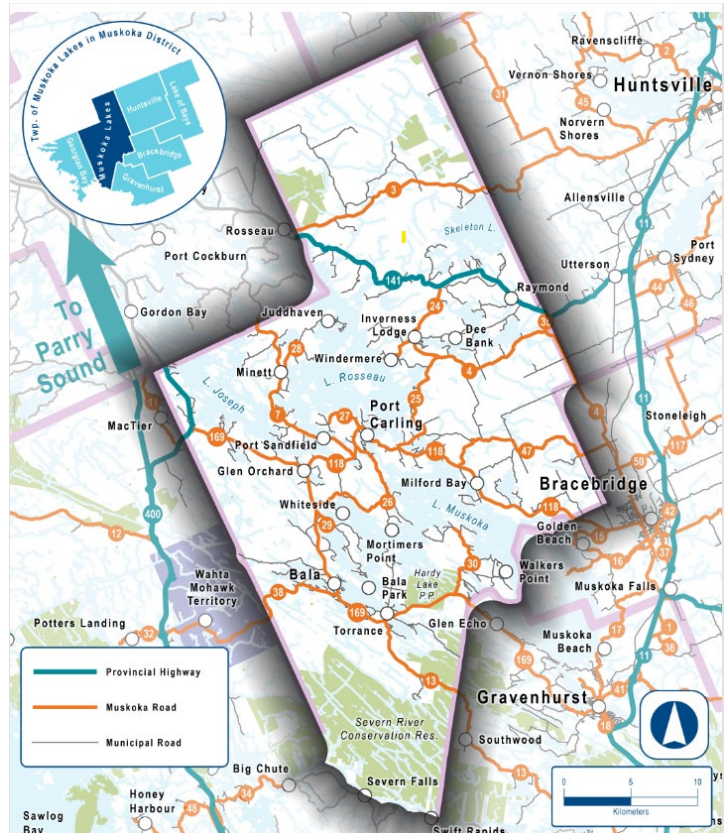
