District Chair and District Councillor Remuneration

Current remuneration (effective January 1, 2026) for the District Chair, Deputy District Chair and District Councillors (not including lower-tier remuneration) is as follows:

District Chair: \$107,903
 Deputy Chair: \$36,362
 District Councillor: \$28,330

In addition to the above-mentioned remuneration, each of the Standing Committee Chairs for next term will receive an additional \$2,000 annually.

Each term of Council sets the remuneration for the following term. By-law 2025-12 was passed in April 2025 and states the following:

“3. Effective January 1 st of 2027, 2028, 2029 and 2030, the annual remuneration for Council members shall be increased as follows:Position	Annual increase starting 01-01-2027
Councillor	\$2,796
Deputy Chair	\$3,108
District Chair	\$4,386

4. In addition to the increases provided in the table above, an inflationary amount shall be added to the annual remuneration for Council members equivalent to the annual economic adjustment approved for the Management and Non-Union jobs effective on January 1st of each year.”

In addition to this, Councillors are reimbursed for mileage incurred while travelling to and from official meetings per District policy. Lastly, Councillors are provided with a technology stipend in January, immediately following the election. The current approved stipend is \$1,692 which is paid once per term.

Council and Committee Meeting Schedule

Muskoka District Council generally meets on the third Monday of the month at 1:00 p.m. in the Council Chamber at 70 Pine Street in Bracebridge. Should a meeting fall on a Statutory Holiday, the meeting will be rescheduled for the Tuesday of the same week. Meeting may be cancelled or rescheduled due to conflicts with provincial conferences such as AMO and ROMA.

Committee meetings follow within the same week on Wednesday and Thursday and commence at 9:00 a.m. In 2025 Muskoka District Council approved a change to the structure of Committees, moving from the current four standing committee, to two. Rath than having six Member plus the District Chair at each Committee, there will now be twelve Members plus the District Chair with equal representation from each of the Towns and Townships.

Committee meeting dates and times are subject to change at the Call of the Committee Chair and with the consensus of the Committee members.

There are also various ad hoc and special committees established from time to time, as the need arises.

Muskoka District Council Inaugural Meeting

The District's Inaugural meeting is scheduled to take place on Thursday November 19, 2026, at 1:00 p.m. At that meeting, the Clerk will administer the Oath of Office to Council-elect before they can move on to the only business at hand – the selection of the District Chair.

Should there be more than one candidate for the office of District Chair, a Meet the Candidate/Debate event will be held on Tuesday November 10 at 1:00 p.m. in the Council Chamber. Additional information will be provided should the need arise.
